Topic: "Life Cycle" of a Play"



Ashlie Corcoran will give us the inside scoop on how she selects plays for the theatre season, and the "life cycle" of a play - how it develops from a playwright's inspiration to performance on a stage.

Ms. Corcoran (she/her) has been the Artistic Director of the Arts Club since 2018, during which time she has The Curious Incident of the Dog in the Night-Time, The Matchmaker, Bed & Breakfast, Cost of Living, The Sound of Music, Redbone Coon-hound, Teenage Dick, Beautiful: The Carole King Musical, and Little Shop of Horrors for the company.

Originally from White Rock, BC, Corcoran directs both theatre and opera, working across Canada and internationally. She was the Artistic Director of the Thousand Is-lands Playhouse in Gananoque, Ontario, from 2012 to 2017, where she directed 15 productions. She is also the co-founder and Artistic Producer for Theatre Smash in To-ronto, a British Foreign and Commonwealth Office Chevening Scholar, and a member of the Lincoln Center Directors Lab. Other credits include The Magic Flute & The Bar-ber of Seville (Vancouver Opera); Me and My Girl (Shaw Festival); Mamma Mia!, Little Shop of Horrors & Cost of Living (Citadel Theatre); Das Ding (The Thing) (Theatre Smash/Canadian Stage/TIP); Kiss (Theatre Smash/Canadian Stage/ARC); The Ugly One, Durango, The Boy Called Newfoundland, Tijuana Cure (Theatre Smash); The Gay Heritage Project (Buddies in Bad Times Theatre/National Tour); Bed & Breakfast (Centaur Theatre/Belfry Theatre); The Ugly One, Mustard (Tarragon Theatre); The 25th Annual Putnam County Spelling Bee, Waiting for the Parade, Driving Miss Daisy, Blithe Spirit, Don't Dress for Dinner, The Birds & the Bees (Western Canada Theatre); and 10 projects at the Canadian Opera Company, most recently The Magic Flute and The Magic Victrola.

NOVEMBER SPEAKER

Associate Chief Justice Heather Holmes

"Court System – Particularly, Changes from COVID"

Honourable Madam Justice Heather Holmes, Associate Chief Justice of the Supreme Court of British Columbia. ACJ Holmes wll briefly described for us the structure of the courts in BC and how the courts are populated with judges. She talked about the "silver lining" for modernization of the courts offered by the Covid-19 pandemic; and noted some of the challenges as well as the successes that have resulted in long-lasting change.

She gave us an over all picture of the court system in BC & Canada, noting that she has presided over some high-profile cases.

In BC, there are 97 Justices covering 30 courthouses. Each Justice spends 4-6 weeks /year traveling to the more remote areas.

Trials are by judge only, vs those with juries.

The courthouses range from multi-story, multi courtroom to single courtroom facilities. During the pandemic, it became necessary to look at options to consider the need to adapt the system for medical safety.

In order to make changes, this had to include:

- considerations of privacy vs public access.
- document management systems were improved

- funding for tech improvements, including:
 - video capabilities
 - increased bandwidth at each of the courthouses, no matter how remote
 - o plexiglass in all areas
- innovative jury selection BC lead the way
- inter-government communication
- inter-lawyer group communication.

The challenges are ongoing, but ever-improving.

Heather was appointed Associate Chief Justice of the Supreme Court of British Columbia in June 2018. She has been a justice of the court since March 2001. Prior to her judicial appointment, and for much of her career as a lawyer, she was Crown Counsel with the Commercial Crime Section, Ministry of the Attorney General of British Columbia.

specializing in securities fraud prosecutions, and commercial crime trials and appeals.

She also spent four years (1991-1995) as counsel with the Criminal Law Policy Section, Department of Justice, Canada, in Ottawa, where she developed recommendations for criminal law reform and provided advice and support to the Minister of Justice.


Have you heard... We're moving!


PGGC notified us that next year they will be unable to accommodate us for 6 months next year.
